To pray in the name of Christ is, in obedience to his command, and in confidence on his promises, to ask mercy for his sake; not by bare mentioning of his name, but by drawing our encouragement to pray, and our boldness, strength, and hope of acceptance in prayer, from Christ and his mediation (John 14:13-14). **WCF Chapter 21. Of Religious Worship, and the Sabbath Day, 3.** Prayer, with thanksgiving, being one special part of religious worship, is by God required of all men: and, that it may be accepted, it is to be made in the name of the Son, (John 14:13–14) by the help of His Spirit, according to His will, with understanding, reverence, humility, fervency, faith, love, and perseverance; and, if vocal, in a known tongue.

WLC Q. 123. Which is the fifth commandment? A. The fifth commandment is, Honor thy father and thy mother: that thy days may be long upon the land which the Lord thy God giveth thee. WLC Q. 130. What are the sins of superiors? A. The sins of superiors are, besides 1) the neglect of the duties required of them, 2) an inordinate seeking of themselves, 3) their own glory, 4) ease, 5) profit, or 6) pleasure; 7) commanding things unlawful, or 8) not in the power of inferiors to perform; 9) counseling, 10) encouraging, or 11) favoring them in that which is evil; 12) dissuading, 13) discouraging, or 14) discountenancing them in that which is good; 15) correcting them unduly; 16) careless exposing, or 17) leaving them to 18) wrong, 19) temptation, and 20) danger; 21) provoking them to wrath; or 22) in any way dishonoring themselves, or 23) lessening their authority, by 24) an unjust, 25) indiscreet, 26) rigorous, or 27) remiss behavior. RPCNA Testimony 23, 15. The Christian, when such action involves no disloyalty to Christ, ought to be involved in the selection of and to vote for civil rulers who fear God, love truth and justice, hate evil, and are publicly committed to scriptural principles of civil government. 16. It is sinful for a Christian to take an oath which compromises his supreme allegiance to Jesus Christ. It is also sinful to vote for officials who are required to take an oath which a Christian himself could not take in good conscience. Voting involves the voter in responsibility for any act required of the official as a condition of holding his office.
