- C. JOASH & THE FIRST TEMPLE (2Chr.24:6,9; contrast Ezra 6:8; Neh.10:32,33)
- D. ROMANS & RESTRAINTS ON REMITTANCES (e.g., Valerius Flaccus, Asia, 62 BC)
- E. JOSEPHUS & TENS OF THOUSANDS CONVOY FROM BABYLON (c.30 AD)
- F. ROMANS & IMITATION FOR PAGAN TEMPLE (the Fiscus Judaicus; after 70AD)

III. THE ROYAL FAMILY & TAXES

- D. USE YOUR FREEDOM AS THE KING'S ADOPTED CHILDREN TO SERVE YOUR NEIGHBORS INCLUDING THE KINGS OF THE EARTH! (Mt.17:27; see III above)
- *E. BE ASSURED OF THE LORD'S PROVISION FOR YOUR SERVICE!* (Mt.17:27; see Gen.22:14; see Lk.6:38; 2Cor.9:6f)
- F. CONSIDER WHETHER THE TEMPLE-TAX PROVIDES A MODEL FOR US! (see II above; see Num.18:28; Ex.35:5f; Acts 10:2f; i.e., "general equity")
- G. CONSIDER THE USE OF OUR FREEDOM FOR SERVICE WITH RPM&M! (25-27; see III above; see bulletin insert)
