Aultman, a retired OB/GYN who is now with the pro-life Charlotte Lozier Institute, has [testified](#) before [Congress](#) on behalf of pro-life laws, and joined LifeSiteNews' Jonathon Van Maren for an interview on [this week's episode](#) of *The Van Maren Show*, where they discussed her experiences and her journey toward the pro-life side.

“The one thing people will say, especially when they see abortion, victim photography or imagery that shows how gory and horrible abortion actually is, they'll say that there's no way that it actually looks like that,” Van Maren said, relaying his own experiences in pro-life outreach. “What did you see in your work as an abortion provider?”

“It's exactly what the pictures show. I mean, how can it be otherwise?” Aultman confirmed. “You're tearing this little body limb from limb, so you get arms and legs and faces. And it's exactly what the pictures portray that you have been out there.”

“We were in a hearing once and I had given a fairly graphic description, very graphic, graphic but honest description,” she recalled. “And one of the members got upset that ‘we had no decorum, and how could I be so graphic?’ And the chairman of the

committee said, ‘well, gosh, if we can't even discuss it, should we be doing them?’”

“Right. If it's too hard to look at, why are we allowing this to happen?” Van Maren responded.

There is disagreement within the pro-life movement on the use of graphic abortion photos as visual aids. Some argue that displaying them is necessary to force people to face the harsh reality of abortion, while others feel their use in certain circumstances can needlessly alienate people who would be reachable through argument and more benign [ultrasound imagery](#).

A 2016 study commissioned by the Canadian Centre for Bio-Ethical Reform [found that](#) viewing graphic abortion images resulted in a 17 percent gain toward a pro-life worldview.

Planned Parenthood has released its 2018-2019 [annual report](#) and it reveals that the abortion provider, in its last fiscal year (ending June 30, 2019), performed its highest yearly number of abortions on record, while also receiving the highest amount of government funding it has ever received in a year.

Planned Parenthood performed **345,672** abortions in the single year ending June 30, 2019

This is the highest number of abortions ever performed by the organization in a single year, and represents a **3.88% increase** over the previous year.

Planned Parenthood received \$616.8 million from taxpayers in its last fiscal year (thru medicaid)

This is the highest amount of government funding the group has ever received, and represents a remarkable 9.4% increase over the previous year.

The non-profit abortion (murder) giant lists total assets of \$2.28 billion, with liabilities of \$285.7 million, for a worth of total net assets exceeding \$1.9 billion:

[c] The report groups revenue by source (either government or non-government) rather than the manner of disbursement (income versus grants and contracts). Payments from Medicaid managed care plans are listed as "Government Health Services Reimbursements & Grants" to reflect the ultimate source of the funds.

The Ohio law known as House Bill 214 that banned abortions which were based on the unborn baby being diagnosed with Down syndrome was **blocked** by a divided federal appeals court.

The law, signed by former Gov. John Kasich in December 2017, would impose criminal penalties on doctors who perform an abortion knowing the woman based her decision to abort on a prenatal diagnosis of Down syndrome.

Circuit Judge Bernice Bouie Donald wrote in a 2–1 decision that the injunction served the public interest by ensuring “access to constitutionally protected health care services.”

“In an unprecedented hearing in California this week featuring Planned Parenthood executives and the undercover videos made by the Center for

Medical Progress, abortion doctors revealed uncomfortable truths about the industry. In one such testimony, Forrest Smith, an obstetrician-gynecologist who performed abortions in California, testified not only that Planned Parenthood and other abortion clinics were selling aborted baby parts for profit, but babies were often born alive, then murdered, in order to ensure the organs to be sold were more fresh and intact.

Smith, who [said he had done at least 50,000 abortions](#), testified that based on what he saw in the videos and what he knows about the abortion industry, he believes doctors performed abortion procedures so that babies would be born alive, even though it puts the mother at greater risk.

Smith testified that he came to this conclusion after reviewing video footage of a presentation [Alisa Goldberg](#) gave at a 2014 Planned Parenthood conference and in another Center for Medical Progress video where a procurement manager for Advanced Bioscience Research talks about a “fetus falling out.”

In her presentation, Goldberg suggested using large doses of misoprostol so a second-trimester induced abortion procedure could be completed in one day. According to Smith, large doses of that drug would

trigger “tumultuous labor” and suggested the baby is often delivered so quickly, it needs no “assistance from the abortion doctor, no instrumentation,” or in another words appears to “fall out” of the mother and is born alive. Smith also testified that “very few people in abortion, outside of Planned Parenthood, do that.”

In a “normal” abortion scenario, the baby’s heart would be stopped with a lethal dose of potassium chloride while still inside the mother’s womb, and then expelled. Of course, this testimony flies in the face of what Planned Parenthood has always said about the Center for Medical Progress videos which is that, at best, they were simply donating organs to science for research and at worst, they were not compromising the healthcare of mom or baby during the process.

I. The Reality of Abortion

In 1973, the Supreme Court handed down its *Roe v. Wade* and *Doe v. Bolton* decisions legalizing abortion in all 50 states during all nine months of pregnancy, for any reason, medical, social, or otherwise.[1]

The vast majority of all abortions performed today are done for social, not medical reasons -- because a woman doesn't feel ready for a baby at the time, because her partner wants her to have an abortion, etc. Approximately 93% of all induced abortions are done for elective, non-medical reasons such as these.[2]

Abortion ends a pregnancy by destroying and removing the developing child. That baby's heart has already begun to beat by the time the mother misses her period and begins to wonder if she might be pregnant (about 31 days after the mother's last menstrual period or LMP). [3] Surgical abortions are usually not performed before seven weeks, or 49 days LMP. [4] By that time, the baby has identifiable arms and legs (day 45)[5] and displays measurable brain waves (about 40 days).[6] During the seventh through the tenth weeks, when the majority of abortions are performed,[7] fingers and genitals appear and the child's face is recognizably human. [8]

Abortion Techniques > Surgical > First Trimester

Suction aspiration, or "vacuum curettage," is the abortion technique used in most first trimester abortions.[9] A powerful suction tube with a sharp cutting edge is inserted into the womb through the dilated cervix. The suction dismembers the body of the developing baby and tears the placenta from the wall of the uterus, sucking blood, amniotic fluid, placental tissue, and fetal parts[10] into a collection bottle.[11]

Great care must be taken to prevent the uterus from being punctured during this procedure, which may cause hemorrhage and necessitate further surgery. [12] Also, infection can easily develop if any fetal or placental tissue is left behind in the uterus. This is the most frequent post-abortion complication. [13]

Abortion Techniques > Chemical > First Trimester

While many people focus solely on RU 486, the so-called "French abortion pill," the RU 486 technique actually uses two powerful synthetic hormones with the generic names of mifepristone and misoprostol [17] to chemically induce abortions in women five-to-nine weeks pregnant.[18]

The RU 486 procedure requires at least three trips to the abortion facility.[19] In the first visit, the woman is given a physical exam, and if she has no obvious contra-indications ("red flags" such as smoking, asthma, high blood pressure, obesity, etc., that could make the drug deadly to her[20]), she swallows the RU 486 pills. RU 486 blocks the action of progesterone, the natural hormone vital to maintaining the rich nutrient lining of the uterus. The developing baby starves as the nutrient lining disintegrates.[21]

At a second visit 36 to 48 hours later, the woman is given a dose of artificial prostaglandins, usually misoprostol, which initiates uterine contractions and usually causes the embryonic baby to be expelled from the uterus. [22] Most women abort during the 4-hour waiting period at the clinic, but about 30% abort later at home, work, etc., [23] as many as 5 days later.[24] A third visit about 2 weeks later determines whether the abortion has occurred or a surgical abortion is necessary to complete the procedure (5 to 10% of all cases).[25]

There are several serious well documented side effects associated with RU 486/prostaglandin abortions, including prolonged (up to 44 days) [26] and severe bleeding,[27] nausea, vomiting, [28] pain, [29] and even death. At least one woman in France died while others there suffered life-threatening heart attacks from the technique. [30] In U.S. trials conducted in 1995, one woman is known to have nearly died after losing half her blood and requiring emergency surgery. [31]

Long term effects of the drug have not yet been sufficiently studied, but there are reasons to believe that RU 486 could affect not only a woman's current pregnancy, but her future pregnancies as well,

potentially inducing miscarriages or causing severe malformations in later children. [32]

Abortion Techniques > Surgical > Second Trimester

Used to abort unborn children as old as 24 weeks, this method is similar to the D&C. The difference is that forceps with sharp metal jaws are used to grasp parts of the developing baby, which are then twisted and torn away. This continues until the child's entire body is removed from the womb. Because the baby's skull has often hardened to bone by this time, the skull must sometimes be compressed or crushed to facilitate removal. If not carefully removed, sharp edges of the bones may cause cervical laceration. Bleeding from the procedure may be profuse. [50]

Dr. Warren Hern, a Boulder, Colorado abortionist who has performed a number of D&E abortions, says they can be particularly troubling to a clinic staff and worries that this may have an effect on the quality of care a woman receives. Hern also finds them traumatic for doctors too, saying "there is no possibility of denial of an act of destruction by the operator. It is before one's eyes. The sensation of dismemberment flow through the forceps like an electric current." [51]

Abortion Techniques: Instillation Methods > Chemical > 2nd & 3rd Trimester

Otherwise known as "saline amniocentesis," "salting out," or a "hypertonic saline" abortion, this technique is used after 16 weeks of pregnancy, when enough fluid has accumulated in the amniotic fluid sac surrounding the baby.

A needle is inserted through the mother's abdomen and 50-250 ml (as much as a cup) of amniotic fluid is withdrawn and replaced with a solution of concentrated salt. [53] The baby breathes in, swallowing the salt, and is poisoned.[54] The chemical solution also causes painful burning and deterioration of the baby's skin. [55] Usually, after about an hour, the child dies. The mother goes into labor about 33 to 35 hours after instillation and delivers a dead, burned, and shriveled baby. [56] About 97% of mothers deliver their dead babies within 72 hours.[57]

Hypertonic saline may initiate a condition in the mother called "consumption coagulopathy" (uncontrolled blood clotting throughout the body) with severe hemorrhage as well as other serious side effects on the central nervous system. [58] Seizures, coma, or death may

also result from saline inadvertently injected into the woman's vascular system.[59]

Abortion Techniques > Surgical > 2nd & 3rd Trimester

Abortionists sometimes refer to these or similar types of abortions using obscure, clinical-sounding euphemisms such as "Dilation and Extraction" (D&X), or "intact D&E" (IDE) which mask the realities of how the abortions are actually performed. [69]

This [procedure](#) is used to abort women who are 20 to 32 weeks pregnant -- or even later into pregnancy.* Guided by ultrasound, the abortionist reaches into the uterus, grabs the unborn baby's leg with forceps, and pulls the baby into the birth canal, except for the head, which is deliberately kept just inside the womb. (At this point in a partial-birth abortion, the baby is alive.) Then the abortionist jams scissors into the back of the baby's skull and spreads the tips of the scissors apart to enlarge the wound. After removing the scissors, a suction catheter is inserted into the skull and the baby's brains are sucked out. The collapsed head is then removed from the uterus.[71]

There is a miracle of Creation. Because more than flesh and bone are being made. More than blood and cells. More than DNA and design. There is a Soul that is created that will outlast the body being made by millions of years.

Life starts at conception, not just a body.

Negative perspective

and

Positive Perspective.

Negative. It is God who closes the womb.

¹⁷ So Abraham prayed to God; and God healed Abimelech, his wife, and his female servants. Then they bore *children*; ¹⁸ for the Lord had closed up all the wombs of the house of Abimelech because of Sarah, Abraham's wife.
