Jesus challenged the crowd to consider the Law. vv. 16, 19, 24

The Pharisees accused the crowd of ignorance of the Law. v. 49

The Pharisees reject the Law out of arrogance. v. 52

- 1. They didn't submit to the Law but sat in judgment over it.
- 2. They used the Law inconsistently to disprove claims, rather than to assess the truth.

- 2. If there is something I don't understand about Scripture, wait until God reveals the consistency of Scripture.
- 3. You must be born again.
