Intro:

<u>Main Point of Text:</u> At the end of forty days on Mt. Sinai with Moses, God prints covenant receipts in stone as an eternal witness to His kingly rule over His purchased people who agreed to His peace treaty sealed in blood.

In the Ten Commandments, we see the document structure of their contemporary Ancient Near East suzerain peace treaty formula between a conquering king (suzerain) and his vassal (servant) subjects. R.C. Sproul describes the elements: 1) *preamble*, where the overlord identified himself over his vassals, Ex. 20:1-2a; 2) *historical prologue*, in which the king summarized their mutual history, Ex. 20:2; 3) *promises and stipulations*, Ex. 20:3-17; 4) *sanctions*, Ex. 19:8; 24:3, 7; 5) *oath /sacred vow* to establish covenant by way of blood ratification, Ex. 24:3-8; and 6) duplicate copies of the covenant were made, one for the king and one for the vassals as a mutual witness, Ex. 31:18 (as promised in 24:12); Deut. 4:13.

Sermon Point: Can I Get a Witness (of Your Covenant Love)?

Move 1: Your King and Husband Has Given a Loving Witness by Delivering and Protecting You. Words on tables are "of the covenant/ten commandments" (Ex. 34:28; Deut. 4:13); Moral Law. God now writes down in formal contract. Suzerain preamble formula: "I/thou", as in Ex. 20:1-2a; historical prologue, the King reviewed their historic relations and benefits to justify his continual reign, as in Ex. 20:2. The context of Sinai was merciful deliverance. The tables of testimony are placed under the Mercy Seat. People first marked by the blood of the Passover Lamb. Tabernacle bears atonement witness. Meredith Kline: God's copy like His rainbow. Acts 20:28. Only God gives eternal guarantee: Jn. 3:16. Heb. 13:20-21.

Move 2: King Jesus Will Rule Over You and Lead You in Perfect and Perpetual Love.

Cut with Own Finger (32:16) in stone: living everlasting life with Him His way in view. Suzerain treaties listed the king's stipulations for life/loyalty in exclusive relationship in his land. So Ex. 20:3-17. Acts 20:28: God purchased the church: ownership. To follow His Law of love: Mt.. 22:37-40 re: Deut. 6:5; Lev. 19:18.

Move 3: King Jesus Reminds You of Your Public Marriage Vows to Always Love Only Him.

Tables of "Testimony" or "witness". In Ark of "Testimony" (31:7), or "Covenant" (Deut. 10:8). Tables also "of the covenant" (Deut. 9:9, 11, 15) witnessed mutual commitment. Standard Ancient Near Eastern procedure made written treaty documents like 31:18 and 32:15 (two copies of same, front and back). Suzerain's dynastic seal of ownership in center (so covenant "sign", vss. 12-17). Copy put in sanctuaries of vassal and suzerain to witness to their oaths. Moses to put both copies in the Ark (Exod. 25:16, 21; Deut. 10:2) in Tabernacle "of testimony" (Ex. 38:21). Kline: Ancient Hittite treaties can be rendered "under (the feet of)" the god. So Two Tables in the Ark, from where God ruled (Ex. 25:22; 1 Chron. 28:2; Lev. 16:2; Num. 7:89; 1 Sam. 4:4). Written marriage vows. Still: 2 Cor. 3:3; Jer. 31:33; Heb. 10:16; Jn. 14:15.
