The Universal Need of Justification:

Explanation for Gentile Guilt

***Read Romans 2:12-16

1- The principle of God's judgment on ALL vv. 12-13

- 2 Principles:

1- “For as many as sinned without law, will also perish without law”

2- “and as many who sinned under law will be judged by the law”

- “will also perish without law”

1- The principle of God's judgment on ALL vv. 12-13

2- “and as many who sinned under law will be judged by the law”

- - “and”
- - “as many”
- - “who sinned”
- - “under law” (what is the “law” mentioned here?)
- - “will be judged by the law” (cf. James 2:8-12)

1- The principle of God's judgment on ALL vv. 12-13

Summary:

- Hearing the law does not produce righteousness
- Doing the law produces righteousness
 - Is this positional or practical righteousness?
***cf. James 2:21-25
 - Can enough righteousness be produced from doing the law to achieve perfect righteousness? NO! Which is Paul's point of this passage.

2- The reason for Gentile guilt before God vv. 14-16

- 6 Facts:

Fact #1: Gentiles do not have the law v. 14b

Fact #2: Gentiles can by nature “do the law” v. 14c

Fact #3: Gentiles are a law in themselves v. 14d

Fact #4: The “work of the law” is written in the heart v. 15a
- (cf. Jeremiah 31)

Fact #5: Gentile conscience testifies against them. v. 15b

Fact #6: Every deed will be judged. v. 16
- (2 Cor. 5:10; Rev. 20:11-13)

2- The reason for Gentile guilt before God vv. 14-16

- 6 Conclusions:

1- A sinner without law will perish v. 12

2- A sinner under law will be judged by the law v. 12

3- Doers and not hearers only are declared righteous v. 13 (the principle)

4- A Gentile who is without law but by nature does the law is a law in themselves. v. 14

5- The Gentile's "thoughts" then accuse or excuse them... But cf. 1:20 v. 15

6- All will be uncovered before Jesus Christ. v. 16
