Colossians 2:8

Proverbs 22:6

Train up a child in the way he should go: and when he is old, he will not depart from it.

Deuteronomy 11:18-21

Therefore shall ye lay up these my words in your heart and in your soul, and bind them for a sign upon your hand, that they may be as frontlets between your eyes. ¹⁹ And ye shall teach them your children, speaking of them when thou sittest in thine house, and when thou walkest by the way, when thou liest down, and when thou risest up. ²⁰ And thou shalt write them upon the door posts of thine house, and upon thy gates: ²¹ That your days may be multiplied, and the days of your children, in the land which the LORD sware unto your fathers to give them, as the days of heaven upon the earth.

In 1962, the US Supreme Court ruled in Engel v. Vitale against school-sponsored prayer – even nonsectarian prayer.

In 1963, the US Supreme Court banned organized Bible reading for religious and moral instruction.

In the 1980 case of Stone v. Graham, the court found unconstitutional a Kentucky law requiring all public schools to post a copy of the Ten Commandments.

In 1985 the Supreme Court case Wallace v. Jaffree, an Alabama law was requiring public schools to set aside a moment each day for silent prayer or meditation.

In 2000 school-sponsored prayers at high school football games were banned.

The Supreme Court ruled in the 1968 case Epperson v. Arkansas, that Arkansas could not eliminate from the high school biology curriculum the teaching of "the theory that mankind descended from a lower order of animals."

Galatians 3:28

There is neither Jew nor Greek, there is neither bond nor free, there is neither male nor female: for ye are all one in Christ Jesus.

Conclusion – Mom and dad, not the government (or the village), are responsible before God to train their children in the ways of the Lord.
