- 5. What are the primary *practical* points? Do you *do* these things?
- 6. How is each "unalienable right" given?
 - a. How is each one forfeited?
 - b. How is each one *restored*?
 - c. What is the duty, power and authority of civil government regarding these rights?
 - d. What does civil government need to do to successfully fulfill their duty and faithfully exercise their power and authority?
 - e. What is the limit of government duty, power and authority?
- 7. What is the definition of "the pursuit of happiness"? (See Wikipedia article under *Life, liberty and the pursuit of happiness*)
 - a. How have you understood this phrase?
 - b. How do you think it is commonly understood today?
 - c. What is the definition in the 1883 concurring opinion by Justice Field?
 - d. How has this phrase been interpreted to give a "right" to "privacy"? What are your thoughts about that interpretation?
 - e. How is the freedom to marry someone from any race in keeping with the biblical notion of "the pursuit of happiness"? (see the reference to the 1967 Loving v. Virginia case; see Gen.2:7f,18f; Ps.128)
 - f. How is faith in Christ the enjoyment of an objective good? (see Phil.3:14,9f; Eph.4:13)
 - g. How is the Lord's Supper "the pursuit of happiness"? (see Jn.6:53; 40&54)
