I. CONSTITUTIONAL CONSIDERATIONS

The Directory of Public Worship (2010), pg. 7: "29. The session should carefully consider how to lead the church in observing the day. Since the circumstances of each congregation vary, the session should carefully consider whether a second meeting should be held, and whether it should be a public worship service or some other gathering for fellowship and edification, always considering the glory of God and the good of the congregation."

- E. CHRISTIAN FELLOWSHIP: SANCTIFICATION VS. ENTERTAINMENT (eg, Eph4:16; see A,B above)
