- **B. TO MAN AS THE IMAGE OF GOD** (Gen.1:26f; see 1Jn.5:1; 3:10; Jms.3:9)
- **C. AUTHORITY: HOLY GOD TO INNOCENT MAN** (Gen.1-3; *human* duty (law); fulfilled *in Christ* (gospel); e.g., no other gods (#1, 1:1), no idols (#2; 1:1f), Name not vain (#3; 1:3f), Sabbath (#4; 2:2), honor parents (#5; 1:26f), sanctity of life (#6; 1:26f), marriage (#7; 2:18f); property rights (#8; 2:16f), truth telling (#9; 2:17/3:1f), contentment (#10; 2:18f; 3:6)
- D. MISSION: BE HOLY AS HE IS HOLY (see 1Pt.1:14f; 2:9f)
- E. VISION: THE HOLY GARDEN CITY (Gen.2:8f; Rev.21:2f; 22:19)
- **F. PATH: LOVING OBEDIENCE** (Mt.22:37f; Ex.20:1f; Jn.14:15,31; see Rom.3:22f; Col.3:9,10; 5f)

- A. MISSION & MEANS OF CHURCH ARE WELL DEFINED (see I; Mt.28:18-20—Acts 2:42f/Acts, Paul)
- B. THE CHURCH HAS AUTHORITY TO STRATEGICALLY PLAN ACCORDING TO ITS MISSION AND MEANS PRESCRIBED ONLY (see Intro.; Mt.15:9; Col.2:20; see Mt.18:15f; Rom.14:4f)
- C. THE CHURCH DOES NOT HAVE AUTHORITY TO STRATEGICALLY PLAN THE LIFE OF ITS MEMBERS IN THEIR NECESSARY EMPLOYMENTS (see II; yet Mt.28:18f)
- D. THE CHURCH DOES NOT HAVE AUTHORITY TO STRATEGICALLY PLAN THE LIFE OF ITS MEMBERS IN THEIR VOLUNTARY ASSOCIATIONS (see III; yet Mt.28:18f)
